The name of the limited liability company is Falcon's Beyond Destinations, LLC.

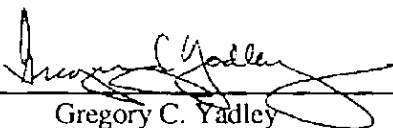
ARTICLE II. ADDRESS
