ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY OF AMERICAN MARKETING SYSTEMS, LLC. SECRETARY OF STATE

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Revised Limited Liability Company Act, as amended, F.S. §605, et.scq. (the "Act"). hereby form a Florida limited liability company (this "Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles"):

ARTICLE I NAME

ARTICLE V REGISTERED AGENT AND OFFICE

The name of the initial registered agent for this Company shall be Steven W. Moore and the street address of the registered agent for the service of process shall be 8240 118th Avenue N., Suite 300, Largo, Florida 33773.

ARTICLE VI ADMISSION OF MEMBERS

The initial members of this Company shall be set forth in the Operating Agreement and Regulations adopted by the members as set forth therein. The admission of additional members shall be accomplished only by a unanimous vote of the members.

ARTICLE IX POWERS

This Company shall have all of the powers and authorities set forth in the Act.

ARTICLE X PROPERTY

- (a) Ownership. All property originally paid or brought into, or transferred to, this Company as contributions to capital by the members, or subsequently acquired by purchase or otherwise on account of this Company shall be the property of this Company.

- (c) <u>Conveyances</u>.
