**ARTICLES OF ORGANIZATION

The undersigned, R. Russel Porter II, a natural person competent to contract and an authorized representative of a member of Freeport Partners, LLC, hereby presents these Articles of Organization as the Articles of Organization of Freeport Partners, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Freeport Partners, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 4947 E. County Highway 30A, Santa Rosa Beach, Florida 32459. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.
