

NEW MEMBERS



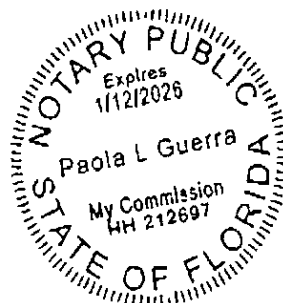
