
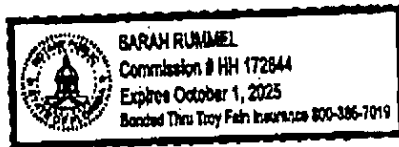
MANAGEMENT
