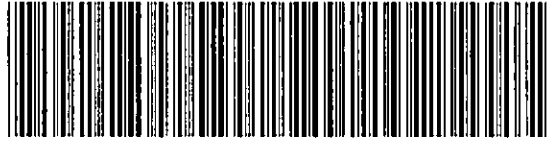

ARTICLE II: ADDRESSES


