**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

WHEREAS, the name of the company is 3-Point Construction & Development, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the undersigned Company, by and through its Members and pursuant to the provisions of Section 605.0202 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization titled Management is deleted and restated as follows:

**ARTICLE IV
MANAGEMENT**

The Company shall be managed by the Managers of the Company as provided in the Company's Operating Agreement. The Managers of the Company are as follows: Kevin Coscia, Gary Coscia, Salvatore LaGambina, Scott Fairbrother, Peter Krog, and David Hart, each of whom shall serve until replaced according to the provisions of the Company's Operating Agreement.

2. The date of the foregoing amendment's adoption was July 1, 2022.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
