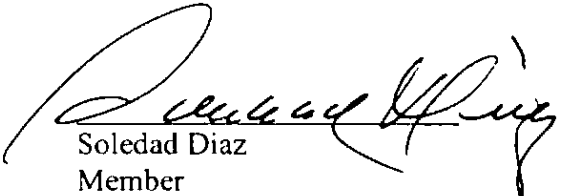
ARTICLE NINE – EFFECTIVE DATE

The effective date of the establishment of this Limited Liability Company shall be the date of the filing of these Articles of Organization with the Secretary of State.

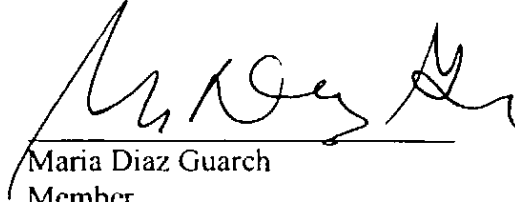
