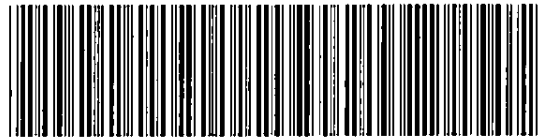


1. The name of the limited liability company is TB HOMES LAND LXXXIII, LLC.
