ARTICLES OF ORGANIZATION OF B AND J PARKWAY PROPERTIES, LLC

The undersigned, WILLIAM V. LEE, a natural person competent to contract and an authorized representative of B AND J PARKWAY PROPERTIES, LLC, hereby presents these Articles of Organization as the Articles of Organization of B AND J PARKWAY PROPERTIES, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is B AND J PARKWAY PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
