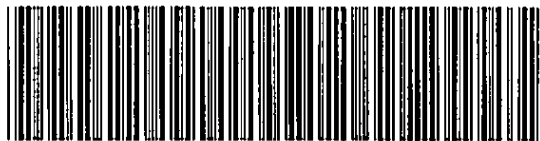

3) Scott Sagharian


