**ARTICLES OF ORGANIZATION
OF
PEOPLES HEALTH SERVICES, LLC**

The undersigned, Timothy A. Buttell, a natural person competent to contract and authorized representative of Peoples Health Services, LLC, hereby presents these Articles of Organization as the Articles of Organization of Peoples Health Services, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Peoples Health Services, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 213 E. Wright Street, Suite B, Pensacola, FL 32501. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE VI - MANAGEMENT




