ARTICLE I
NAME

The name of the Company shall be: **DONNA V. SMITH, PLLC**

ARTICLE II
ADDRESS AND PLACE OF BUSINESS

The mailing and street address for the Company's principal office is 545 Channelside Drive, Suite 806A, Tampa, Florida.

ARTICLE III
GENERAL POWERS

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes.

ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT

The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Chapter 605, Florida Statutes.
