ARTICLE VI – ADDITIONAL CAPITAL CONTRIBUTIONS

The Operating Agreement and/or Regulations, if any, or otherwise the minutes of the Company, shall determine the manner in which such **Manager(s)** are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law or these Articles of Organization.
