TO  
ARTICLES OF ORGANIZATION

**WHEREAS**, the name of the company is Largo Development Management, LLC, a Florida limited liability company ("Company"); and

**WHEREAS**, the Company was formed pursuant to the laws of the State of Florida on April 21, 2022 and assigned document number L22000166579; and

**WHEREAS**, the Members of the Company have recommended the amendments to the Articles of Organization set forth below; and

**WHEREAS**, the undersigned Company, by and through its Members and pursuant to the provisions of Section 605.0202 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

**NOW, THEREFORE**, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization titled Management is deleted and restated as follows:

ARTICLE IV  
MANAGEMENT

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement. The Manager of the Company is Gary Coscia, who shall serve until replaced according to the provisions of the Company's Operating Agreement.

2. The date of the foregoing amendment's adoption was May 24, 2022.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
