**ARTICLES OF ORGANIZATION
OF INNER ACTIVE SCIENCE LLC
a Florida limited liability company**

The undersigned, BOBBIE BROOKS, competent to contract and an authorized representative of INNER ACTIVE SCIENCE LLC, hereby presents these Articles of Organization as the Articles of Organization of INNER ACTIVE SCIENCE LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is INNER ACTIVE SCIENCE LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE V - REGISTERED OFFICE AND AGENT




