4. Place of Principal Office. The mailing and street address of the Company's principal office is 2000 E. Edgewood, Suite 102, Lakeland, FL 33803.

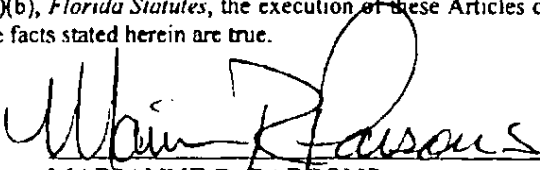
