ARTICLES OF ORGANIZATION FOR PAYTON PROPERTIES, LLC

The undersigned, Joseph Payton and Jonathan Smalls, for the purpose of forming a Limited Liability Company under the Revised Florida Limited Liability Company Act, Florida Statues Chapter 605, hereby makes and acknowledges, and files the following Articles of Organization.

<u>ARTICLE 1 - NAME</u>

The name of the "Limited Liability Company" shall be **PAYTON PROPERTIES, LLC** ("Company").

ARTICLE 2 - PURPOSE

The purposes for which the Limited Liability Company is formed:

- (1) To manage, purchase, sell and lease commercial and residential real estate.

ARTICLE 8 - DURATION

ARTICLE 10 - TERMINATION OF EXISTENCE

ARTICLE 11 - MEMBER'S LIABILTY TO COMPANY
