**ARTICLES OF ORGANIZATION
OF

The undersigned, Kristin Turner, a natural person competent to contract and an authorized representative of a member of InspirED Instructional Leadership, LLC, hereby presents these Articles of Organization as the Articles of Organization of InspirED Instructional Leadership, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is InspirED Instructional Leadership, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 10919 Skymont Drive, Huntersville, North Carolina 28078. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement of the Company. The names and addresses of the initial managers of the Company are as follows:




