**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF

These Articles of Amendment to the Articles of Organization of Green Energy Construction, LLC, a Florida limited liability company (the "Company"), are executed by the undersigned manager of the Company, for the purposes set forth herein.


