**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **PRA43, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **215 5th Ave. NE., St. Petersburg, Florida 33701.**

6. Purpose; Operating Agreement. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida. The members shall have the power to adopt, alter, amend, repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
