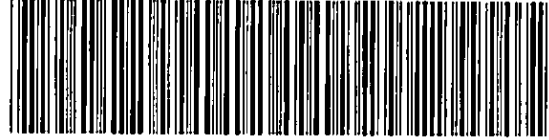



The mailing address and street address of the principal office of the Company shall be 6141 W. Suburban Drive, Pinecrest, Florida 33156.


**ARTICLE III. REGISTERED AGENT AND OFFICE**
