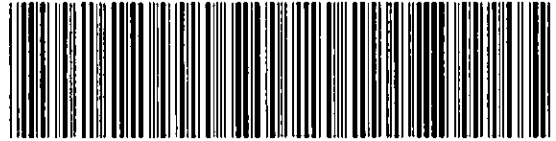

The name of the Limited Liability Company is DB CONSTRUCTION & PAINTING, LLC.


