**ARTICLES OF ORGANIZATION
OF

The undersigned, CHRISTIAN DUGAS, a natural person competent to contract and an authorized representative of CJD, LLC, hereby presents these Articles of Organization as the Articles of Organization of CJD, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is CJD, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal address of the Company is The Family Office, LLC, 333 11th Avenue South, Suite 500, Nashville, Tennessee, 37203. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is for any other legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

ARTICLE V - REGISTERED OFFICE AND AGENT

ARTICLE VI - MANAGEMENT
