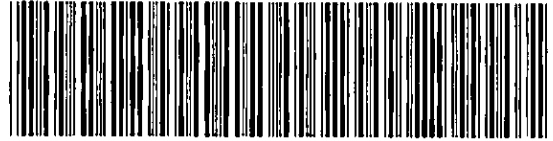

The name of the limited liability company is HAFFNER COASTAL, LLC.


**ARTICLE II. ADDRESS**
