

ARTICLES OF ORGANIZATION FOR T. DAVENPORT, LLC A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 605 of the Florida Statues, hereby adopt the following Articles of Organization for such Company:
