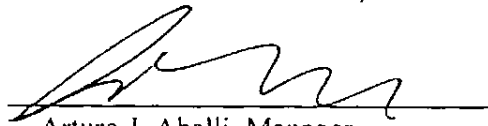
## ARTICLES OF DOMESTICATION
