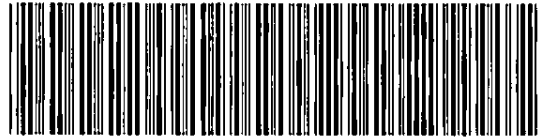



ARTICLES OF ORGANIZATION
OF






