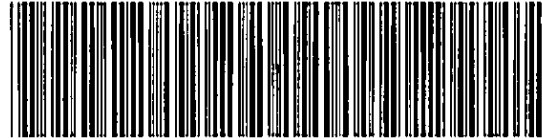

Our company MACHADO AUTO SALES LLC, was filed on or about 03/19/2010. We do not know who KRISSIA HARPAUL is nor did she get permission nor authorization to use our business information.

I have attached the police report, my sunbiz corp papers and the corporation papers filed fraudulently by the individual that goes by the name of KRISSIA HARPAUL. Please remove this fraudulent corporation, as it is a danger to our customers, potential customers and that of our small business. I had to report this to the

City of Miami Police Department, Department of Motor Vehicles dealer services, Consumer Report, Sunbiz.org at CorpHelp@dos.myflorida.com back in 06/06/2022. On or about, 07/15/2022 at approximately 2:29p.m.,
