MANAGEMENT**

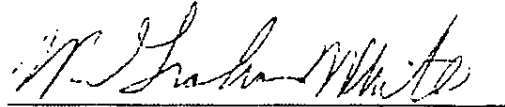

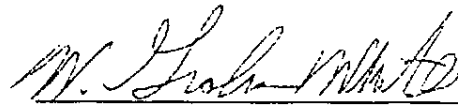
