ARTICLE IV

Manager

The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The designation, authority, and duties of the Manager shall be as set forth in the Operating Agreement of the Limited Liability Company.

ARTICLE V

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
