

STATEMENT OF CORRECTION TO ARTICLES OF ORGANIZATION OF FLOWER & COMPANY LLC

(a Florida limited liability company)

Pursuant to the provisions of section 605.0209 Florida Statutes, this document is being submitted to correct the Articles of Organization of Flower & Company LLC:

FIRST: The name of this Florida limited liability company is FLOWER & COMPANY LLC (the "Company").
