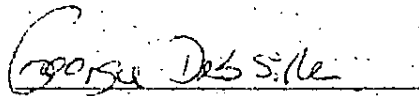
ARTICLE IX - TERMINATION OF EXISTENCE

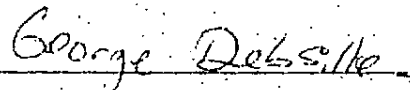
