**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605, Florida Statutes, the undersigned limited liability company (the "Company") adopts the following Articles of Amendment to its Articles of Organization, which were initially filed on May 12, 2022 (the "Articles of Organization"):

1. The name of the Company is SPACE COAST TRANSPORT LLC.
2. Pursuant to a unanimous written consent of the managers and sole member dated as of May 16, 2022, the Company's managers and member have approved and proposed that the Company adopt the following amendment to the Articles of Organization, and the Company has approved and adopted said amendment pursuant to the same unanimous written action.
3. Article I of the Articles of Organization is hereby amended and restated to read as follows:

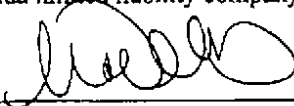
**"ARTICLE I
