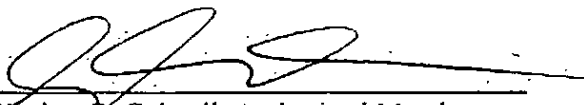
ARTICLE IV – MANAGEMENT OF THE COMPANY
