**ARTICLES OF ORGANIZATION
OF
PJP-NDL, LLC**

The undersigned authorized representative does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "*Company*") under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the Company shall be: **PJP-NDL, LLC.**

**ARTICLE II
ADDRESS AND PLACE OF BUSINESS**

**ARTICLE III
EFFECTIVE DATE; PERIOD OF DURATION**

The effective date of the Company's formation shall be upon filing. The period of duration of the Company shall be perpetual.

**ARTICLE IV
GENERAL POWERS**

The Company shall have the power to conduct and undertake, any and all other business purposes, activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE V
MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of the managers and, except as otherwise provided in the operating agreement of the Company ("*Operating Agreement*"), the business and affairs of the Company shall be managed by or under the direction of the managers ("*Managers*"). ARTICLE VI OPERATING AGREEMENT

The member(s) of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed, altered or amended only in the manner now or hereafter prescribed therein, and consistent with the laws of the State of Florida.


ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT


