ARTICLES OF ORGANIZATION
OF

The undersigned, being an authorized representative of the Member(s) of the Company, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, do hereby adopt the following Articles of Organization:

ARTICLE I
NAME

The name of the limited liability company is CERTEZA AVIATION I, LLC (the "Company").
