**Article I
Name**

The name of the limited liability company ("Company") is **JOSHUA MATUSIK LAWCARE, LLC.**

**Article II
Address**

The mailing and street address of the Company's principal office is 11934 LIZARD LANE, UMATILLA, FL 32784.

**Article III
Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

**Article IV
Purpose and Powers**

This Company is organized with a general business purpose, and has all powers provided by law and may use those powers to any lawful purpose.

**Article V
Registered Agent and Office**

Admission of New Members**

Members of the Company have the right to admit new members. Members may admit to the Company additional members to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the members. The business may be continued only on the unanimous consent of the remaining members.


