ARTICLES OF ORGANIZATION
FOR
9042 MANCHESTER LANE, LLC

The undersigned authorized representative of a Member of 9042 MANCHESTER LANE, LLC (the "Company") hereby executes and adopts the following Amended and Restated Articles of Organization pursuant to Chapter 605, Section 605.0202, Fla. Stat. under the Florida Revised Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on May 23, 2022:

**"ARTICLE I
NAME**

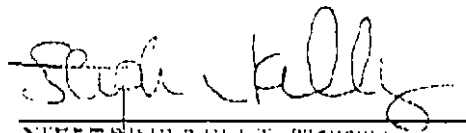
**ARTICLE IV
