ARTICLES OF ORGANIZATION OF IRVINE GARMENT HOLDINGS, LLC

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLEI

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Irvine Garment Holdings, LLC (the "Company"). The Company's principal address and mailing address is 1227 N. Franklin Street, Tampa, Florida 33602.
