GENERAL MAGISTRATE'S REPORT AND RECOMMENDED FINAL JUDGMENT PETITION FOR CHANGE OF NAME (ADULT)

This matter came before the General Magistrate on August 10, 2022 for a hearing on the Amended Petition for Change of Name (Adult) (docket no. 2, filed on May 10, 2022). - 3. The Petitioner has a criminal history, but the incident occurred many years ago, was resolved, and presents no concerns related to this request for a name change.
- 4. The Petition filed is facially sufficient pursuant to the terms of §68.07. Fla. Stat.
- 5. The Petition is filed for no ulterior or illegal purpose and granting it will not in any manner invade the property rights of others.

RECOMMENDATIONS

- 1. The petition for name change is granted.
- 2. The Petitioner shall be known hereafter as Ke'lanne Michelle Torbert.

It is further recommended that the Court enter its order confirming this recommendation.
