**ARTICLES OF ORGANIZATION
FOR

(A Florida Limited Liability Company)

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, pursuant to the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization:

**ARTICLE 1
NAME**

The name of the Limited Liability Company is BLACK HAMMOCK ICW, LLC (the "Company").

DURATION**
