**ARTICLES OF ORGANIZATION  
OF  
SOUTHEAST AIR AMBULANCE, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

**ARTICLE I – NAME**

The name of this limited liability company (the "Company") is **SOUTHEAST AIR AMBULANCE, LLC**.

**ARTICLE II – ADDRESS**

The initial address of the principal office and the mailing address of the Company is 7791 Baymeadows Road East, Suite 7, Jacksonville, Florida 32256.

**ARTICLE III – INITIAL REGISTERED OFFICE AND AGENT**


