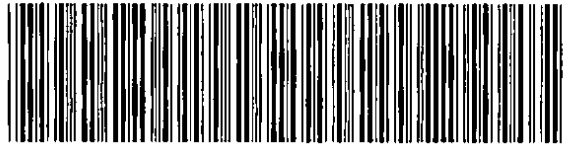

OF

The mailing and the street address of the principal office of the Company shall be 3812 Gunn Hwy, Tampa, FL 33618.

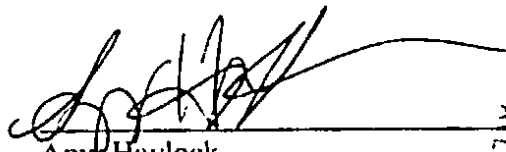
ARTICLE III. REGISTERED AGENT AND OFFICE

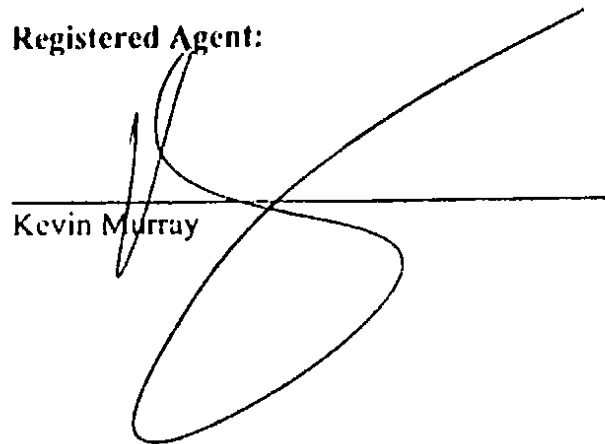
