ARTICLES OF ORGANIZATION OF GOLF SHOTS PCB, LLC

The undersigned, Richard C. Southerland, a natural person competent to contract and an authorized representative of Golf Shots PCB, LLC, hereby presents these Articles of Organization as the Articles of Organization of Golf Shots PCB, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Golf Shots PCB, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”
