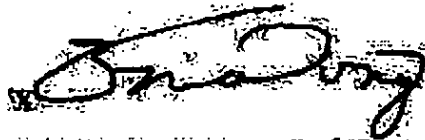

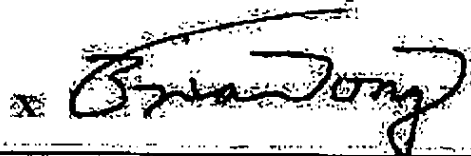
Admission of Additional Members
