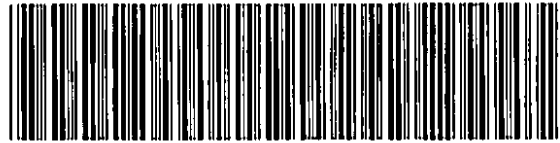


This Statement of Correction corrects the Company's Articles of Organization filed with the Florida Department of State on May 27, 2022 as Document Number L22000231864, as follows.
