**ARTICLES OF ORGANIZATION
OF
VIRTUAL MEDICAL CENTER RADIOLOGY, LLC**

The undersigned, acting as the organizer of Virtual Medical Center Radiology, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts, the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is Virtual Medical Center Radiology, LLC (the "Company").

ARTICLE II - Address:

The mailing address and street address of the principal office of the limited liability company is 100 South Spooky Lane, Unit 7D, Santa Rosa Beach, FL 32459.

ARTICLE III - Duration:

ARTICLE VII - Initial Registered Agent and Office:

The initial registered agent for the Company shall be Capitol Corporate Services, Inc., and the street address of the Company's initial registered office is 515 East Park Avenue, 2nd Floor, Tallahassee, Florida 32301.

ARTICLE VIII - Amendments:

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated in accordance with the terms of the Operating Agreement of the Company.

ARTICLE IX – Continuation of Business:

Unless dissolved in accordance with the Company's Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member.
