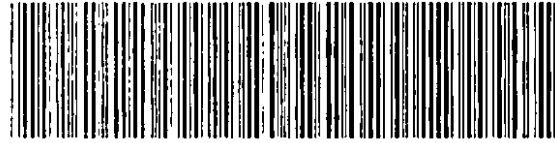

MANAGEMENT**




