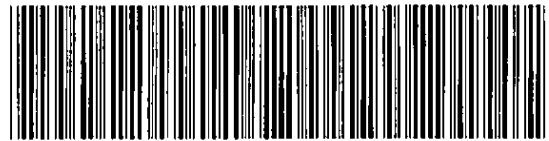

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS



OTHER PROVISIONS


